Membership and Pick-up

As members of Fresh and Local CSA, you will be able to choose a pick-up site that is convenient to you. There are sites in Bethesda (Carderock), Silver Spring, 16th St Heights, Tenley, AU, Arlington and Shepherdstown, WV. There will also be a range of time to pick up your share. (Usually, between 4PM and 10PM) If you do not pick-up within that window, your share for that week will be forfeited. We cannot refund your money for any missed pick-ups. Shares are NOT transferable. If you have a friend pickup for you, that friend must be "trained." Unclaimed shares are donated to charity, when possible. (See website for current list of drop sites.)

Fresh and Local CSA agrees to supply this shareholder with their share of the weekly harvest. It should be noted that implicit in the CSA relationship is the concept of "share the risks and share the bounty," which means that the farmers will work with all their might to provide you with more food than you contracted for but expect you to understand when weather, pests, labor problems or other 'Acts of God' throw a curve and the season does not perform to the farmer's expectations.

In the spirit of CSA as a relationship between farmers and the people who eat from the farm, the CSA farmers hope that members will plan to donate 4 hours of time to the CSA across the season. Hopefully, this will be by doing pleasant group chores (such as weeding) at the farm, but it can be at the delivery site and, possibly, at your PC.

Flower share: \$100 each (Flower Shares start around mid-July and usually run until frost. Typically, you will receive 10-12 bouquets a season. These radiant flowers are grown with the biodynamic preps and without chemicals.) _____

Egg Share : Our eggs are produced by the Joel Salatin method. This means that our layers have access to plenty of grass and greens and insects as well as free-choice access to locally milled grains. They taste AWESOME!
